**Note:** In case if there are no candidates in any of the subjects, those seats will be filled up with suitable candidates of other disciplines / faculties.

**Qualifications:** Master's Degree in the concerned faculty and major field with a minimum of 50% marks in traditional system or OGPA of 7.50 / 10.00 or 3.25/4.00. SC/ST candidates with a pass in traditional system or OGPA of 7.00/10.00 or 3.00/4.00 are eligible. Basic degree i.e. B.Sc.(Ag.), as the case may be is essential. In-service teacher of ANGRAU with M.Sc. in pure science is also eligible, provided he/she has put in a total regular service of not less than ten years as a teacher in the ANGRAU in the concerned subject. The in-service candidates who have put in minimum 3 years of service / whose probation was declared are eligible for admission. They will be permitted to study for two semesters with pay and allowances.

**Age:** The upper age limit is 47 years (relaxable by 5 yrs for women / SCs / STs) of age as on 01-07-2020.

The upper age limit is 47 years (relaxable by 5 yrs for having benchmark disabilities) of age as on 01-07-2020.

**Reservation:** 15%, 6%, and 29% of the seats in each faculty are reserved for SC, ST & BC. Categories, respectively. 3% seats are reserved for Differently abled candidates as per Govt. norms.

**Criteria for Selection:** The selection shall be based on Qualifications, Regular Service in the ANGRAU, Service in Remote areas of the ANGRAU, Publications, Achievements and Interview.

**Places identified as Remote Areas:** Darsi, Jangamaheswarapuram, Mahanandi, Pulla, Ghantasala, Elamanchili, Madakasira, Pulivendala, Chintapalli, Pandirimamidi, Rastakuntabai, Seethampet and Somasila

**Submission of Applications:** The in-service teachers should submit their applications in the proforma (Annexure) along with copies of certificates to their respective Heads of Offices well in advance so as to enable them to verify the particulars furnished in the applications and forward them so as to reach the Registrar, A.N.G.R. Agricultural University, Guntur - 522 034: AP, on or before **26-10-2020 by 4.00 PM** in an envelope superscribed as "**Application for Ph.D. Admissions-2020-21 - Inservice**". To avoid delay, the advance copy shall be sent so as to reach the Registrar, ANGRAU, Guntur before the due date.

Endorsement of the Head of Office at the space provided in the Application is sufficient and separate covering letter is not required. The Heads of Institutions/Offices are requested to bring this to the notice of all concerned/display in the notice board and also to ensure that the applications submitted by the candidates are promptly forwarded so as to reach the University before the prescribed date.
