One seat is available in M.Sc.(Ag.) Course during the Academic Year, 2020-21 for the inservice candidates who have put in **5 years of service** as Asst. Res. Officers / Research Assistants / Agril. Assistants / Agril. Officers / Agril. Extension Officers or equivalent cadre in ANGRAU.

Major fields offered: The candidates can apply for admission into any of the following disciplines in which M.Sc.(Ag.) programme is available. i.e. Agronomy, Agril. Economics, Entomology, Agricultural Extension, Genetics & Plant Breeding, Crop Physiology, Plant Pathology, Soil Science, Agricultural Microbiology, Seed Science & Technology and Agricultural Statistics.

Qualifications: B.Sc.(Ag.) with at least 50% marks in traditional system or an OGPA of 2.50 / 4.00 or 7.00/10.00 under grade point system. However, SC/ST candidates with 40% marks in traditional system or an OGPA of 2.00/4.00 or 6.50/10.00 are eligible.

Age: The upper age limit is 45 years as on 01-07-2020.

Criteria for Selection: The selection shall be based on the marks obtained in B.Sc.(Ag.) examination and service. The weightage for these are as follows:

B.Sc. (Ag.) Marks (OGPA) **50 marks**
Service **50 marks**

(1 mark for each year of service as Sub.Asst / AEO and 2 marks for each year of service as Asst. Res. Officer / Res. Asst. / Agril.Asst. / Agril.Officer)

100 Marks

How to apply: The inservice candidates should apply in the proforma (**annexure**) duly furnishing all the particulars and submit the same to their respective Heads of Offices, well in advance, so as to enable them to verify the particulars and forward the applications to the **Registrar, Acharya N.G. Ranga Agricultural University, Guntur - 522 034: AP** so as to reach on or before **26-10-2020 by 4.00 P.M.** The envelope containing the application should be superscribed as '**Application for M.Sc. admission – In-service**'. Advance copies of application alongwith certificates may be sent so as to reach by the above date if delay is anticipated in forwarding of applications by Heads of offices.

All the Heads of Offices are requested to bring this to the notice of all concerned / display the same in the notice boards and also to ensure that the applications submitted by the candidates are promptly forwarded so as to reach the University by the prescribed date.
