Instructions to Candidates

Eligible candidates who have applied are requested to attend the manual counselling in person on **15/09/2026 at 10:30 A.M.** at **Krishna Auditorium, Regional Agricultural Research Station, Lam Farm (Amaravati Road), Lam, Guntur – 522034.** The candidate who secures a seat shall pay the prescribed fee at the time of counseling in the form of cash as detailed below.

Note I:

- **Candidates who applied in 1st phase and failed to attend the manual counselling conducted on 18/08/2026 are also eligible to attend 2nd phase manual counselling.**
- Candidates called for counseling shall attend at their own cost.
- The candidature of all applicants in the entire admission process is “PURELY PROVISIONAL”, pending scrutiny of eligibility as per the Information Brochure.
- For other details, the candidates are advised to read the Information Brochure thoroughly.
- Fee once paid will not be refunded. In case, if any student desires to cancel his/her after admission then seat cancellation fee has to be paid in excess.

Note II:

The following certificates in Original shall be produced at the time of manual counseling.

- Two conduct certificates one from the College or School where the candidate last studied and the other from an officer of the State Government or any other respectable person.
- Transfer Certificate from the College or School where the candidate last studied.
- Pass Certificate cum Memorandum of Marks obtained by the candidates in the qualifying examination
 - The Community Certificate in the case of candidates belonging to Backward Classes, Scheduled Castes and Scheduled Tribes, signed by the competent authority.
 - In case of PH (Differently Abled) candidates, a valid disability certificate.
 - For EWS category, a valid EWS certificate
 - Farmers Quota Certificates - Form I and Form II : 2026-27 – Issued by competent authority
- Three passport size photographs.
- An Income Certificate of father / mother signed by any Officer not below the rank of the Mandal Revenue Officer of the Revenue Department of the Mandal concerned.
- Physical fitness certificate issued by a Govt. Doctor not below the rank of Assistant Civil Surgeon.

2. The provisional list of NCC/Sports/ Physically Handicapped (Differently Abled) / Defense Personal will be verified.
3. The candidature of all applicants in the entire admission process is "PURELY PROVISIONAL" pending scrutiny of eligibility as per the Information Brochure.
4. In case, it is found at any stage of admission that the applicant does not fulfill the eligibility criteria and any information/document provided by the applicant is found to be false or is not in conformity with the eligibility criteria mentioned in the Information Brochure AY– 2026-27 including Age, Caste Category, Sub-Category, Educational Qualification, etc. the candidature of such applicant will summarily be rejected at any stage of admission process and even after admissions.
