* Master's Programmes in Agriculture under Advanced Post Graduate Centre, Lam, Guntur will be offered at different campuses viz., Agricultural College, Bapatla [Agromony (Water Management)], Environmental Sciences & Agricultural Microbiology) and S.V. Agricultural College, Tirupati (Seed Science & Technology & Molecular Biology & Biotechnology).

Master's Programmes in Home Science under Advanced Post Graduate Centre, Lam, Guntur will be offered at College of Community Science, Lam, Guntur.

II. ACADEMIC ELIGIBILITY AND SELECTION PROCESS: Applicant possessing Bachelors Degree in the concerned subject of Agriculture/Agricultural Engineering and Technology/Home Science/Community Science is eligible to seek admission to M.Sc. degree with a minimum OGPA of 6.50 in 10.0 scale or its equivalent percent of marks. **Candidate must have Bachelors degree from Institute/Colleges having ICAR accreditation and affiliated colleges with SAUs having ICAR accreditation and selection of the candidate will be made based on UG merit and interview at the ratio of 75:25.** The NRI candidates having Bachelors Degree in the concerned subject of Agriculture/Agricultural Engineering and Technology/Home Science/Community Science in any foreign university abroad is also eligible to seek admission to M.Sc. degree programme. Such candidates shall also enclose certificate of English ELTS/TOFEL (Certificate not required for Indian Students studied in English medium).

III. DURATION, MEDIUM OF INSTRUCTION, SYSTEM OF EDUCATION OF DEGREE PROGRAMMES -:

Masters Degree including MBA (ABM): A minimum of two academic years (4 Semesters) shall ordinarily be required for the completion of course work. Research. Thesis/Project report preparation and examination leading to the award of Master's degree.

System of Education & Medium of Instruction: Masters degree programmes are taught under semester system in English medium only.

IV. ADMISSION PROCEDURE: The admission committee so constituted will prepare the list of eligible candidates based on merit considering the eligibility requirements prescribed for admission and recommend to the University for necessary approval and upon approval, the Registrar will notify the same and communicate to the concerned. The academic rules and regulations of Master's degree programme shall also apply for NRI Students.

V. RESERVATION OF SEATS: The seats shall be reserved in favour of **NRI sponsored candidate** with intake under NRI quota be limited to 20% (Supernumerary and including EWS quota but excluding ICAR quota) of existing intake capacity (34 seats) across the three faculties viz., Agriculture, Agricultural Engineering & Technology and Community Science.

Each department shall be allotted a minimum 2 seats in Agriculture faculty, 1 seat to each department in Agricultural Engineering & Technology and Community Science subject to the availability but not more than 5 seats to any department subject to the availability and demand within the frame of 20% NRI quota and seat allotment can be inter transferable among the faculties.

Admission will be made as per the recommendations of the P.G. Admission committee based on the merit of the candidate in the given discipline.

VI. FEE STRUCTURE:

NRI sponsored candidates shall pay Institutional Economic Fee of US \$ 6000/- (or equivalent Indian currency) for Master's degree programme/MBA (ABM) (per annum) along with other Regular University fee on par with other regular students every semester as prescribed by University from time to time. The Institutional Economic Fee so prescribed has to be paid at the beginning of 1st and 3rd semesters.

1. The fees prescribed may change from time to time
2. One US \$ in equivalent to Indian rupee as per the existing rate on the date of payment.
3. If the Candidates admitted under NRI quota fail to complete the Masters degree programmes within the 4 years of maximum time limit, he/she shall pay the University regular fee and other fee/charges as prescribed for every year during subsequent semesters/year till the completion of the degree programmes as per PG regulations.

University Regular Fee:

In addition to the Institutional Economic fee of US\$ 6000 per annum, the candidates who are granted admission shall pay the prescribed regular fee at the time of joining the college and hostel.

The selected candidates has to pay the entire fee (**Approximately Rs.40,000/-**) at the time admission on the day of counselling itself.

* Institutional Economic Fee once paid will not be returned if a candidate cancel seat after taking admission. However to consider such cases, student need to apply for cancellation of seat at least, one day before last counselling.

VII. APPLICATION AND FEE:

The duly filled in application along with the photostat copies of educational documents and notarized affidavit of the Undertaking by the parent and candidate, including physical fitness from the Government Hospitals, DD for Rs.1500/- (Rupees Fifteen Hundred only) towards application fee drawn in favour of Comptroller, ANGRAU, Lam, Guntur shall be submitted to the Registrar. ANGRAU, Lam, Guntur by post or personally during office hours on working days (Monday to Friday from 10.30AM to 5.30PM.)

General Eligibility Norms for seats under NRI sponsored Quota

NRI Category:

The candidates who are claiming under NRI quota shall satisfy the following:

- I. Applicant shall be the ward of NRI or NRI citizen by him / herself.
- II. The NRI sponsorer shall be
 - a) Holding the OCI/PIO/Permanent citizenship status.
 - b) Employment in abroad/ business
 - c) Shall have the annual income sufficient to support the course of study of his/her ward.

NRI sponsored category:

NRI sponsored candidates will be considered subject to fulfillment of the following:

- (a) The sponsorer shall be either related to the applicant (i.e., father, mother, brother or their children, sister or their children, maternal uncle or his children, maternal aunt or her children, paternal uncle or his children, paternal aunt or her children, maternal grandfather, maternal grandmother, paternal grandfather and paternal grandmother) (or) willing to sponsor a candidate known to him / her.
- (b) NRI status certificate issued by the competent authority.
- (c) Copy of the passport with valid VISA.
- (d) The sponsorer with student/ visiting VISA or temporary VISA of any nature is **not eligible to sponsor.**
- (e) Shall have the annual income sufficient to support the course of study of his/her ward.

UNDERTAKING BY THE PARENT & CANDIDATE:

The sponsored candidate and parent is required to give an undertaking in the format appended as **Annexure-I** on Non-Judicial stamp paper worth Rs. 200/- duly Notarized.

UNDERTAKING BY THE SPONSORER:

The sponsorer shall give an undertaking in the format appended as **Annexure-II** on Non-Judicial stamp paper worth Rs. 200/- or equivalent currency in sponsorer's country duly notarized to the effect that he/she would pay the prescribed fee regularly to the University. In the event of non-payment of fee, the student shall be terminated from the course/studies without any notice.

Hostel facility:

Hostel facility shall be provided subject to the availability of accommodation.

List of Enclosures to be submitted with application

The candidates for admission under NRI sponsored quota into PG programme of the University course are required to submit the following enclosures

- (i) An undertaking by the candidate and parent on Rs. 200/- stamp paper dully Notarized (**ANNEXURE-I**)
- (ii) An undertaking by the sponsorer on stamp paper (Rs. 200/- or equivalent currency in sponsorers country) dully notarized (**ANNEXURE-II**)

Certificates/Documents (Attested photocopies only) along with application form.

- a) Pass Certificate cum Memorandum of Marks obtained by the candidates in all the qualifying examination (UG degree Programme PDC/Intermediate/12th class/ or its equivalent)
- b) SSLC or SSC or H.S.C. certificate, showing the evidence of the Date of Birth.
- c) Bonafied / Study Certificates for VI to XII Class.
- d) Bonafide/Conduct Certificate issued by the Head of Institution last attended
- e) Transfer Certificate/Migration Certificate issued by the Head of the Institute/University last attended (whichever is applicable)
- f) Medical fitness Certificate
- g) Self certification documents of sponsorer showing the proof of NRI status, work permit, business establishment, valid VISA, along with the bank statement showing the latest transaction of the previous 6 months.

GENERAL INSTRUCTIONS

- Candidates are required to read the Information Brochure thoroughly before filling in the application.
- Candidates called for the manual counseling shall have to attend with all Original Certificates submitted along with the application form at their own cost.
- After the last date of submission of filled in application, the eligible list, merit list, selected list and last date for admission will be displayed in the University Web site.

- On receipt of selection letter, the candidates shall confirm his/her willingness to join the programme in writing for which he/she has been provisionally selected for admission. No change of subject / campus is entertained subsequently.
- The University will not own the responsibility of candidate's involvement in any unlawful activities during the period of his / her study and candidate himself / herself is solely responsible to appear for any enquiry by the police.
- The confirmation of the admission is subject to the verification and correctness of all original transcripts/certificates, of prescribed fees and fulfillment of all other admission requirements by the concerned authority.
- Payment should be made only in US \$/equivalent Indian rupees.
- The College and Course will be allotted based on the merit and/or by option to respective campus and the seats available in the particular college as per the seat matrix issued by the University.
