Remuneration (per month)	a) Rs.61,000/- + Applicable HRA for Master's Degree holders. b) Rs.67,000/- + Applicable HRA for Ph.D. Degree holders.

**B) Terms and Conditions:**

- 1) The individual is engaged **purely on temporary and contractual basis** which will be terminated after completion of 11 months (or) filling of regular staff, whichever is earlier.
