**B) Terms and Conditions:**

- 11) The individual is engaged purely on temporary and contractual basis which will be terminated after completion of 11 months (or) filling of regular staff, whichever is earlier.
- 12) The incumbent shall not have any claim (or) shall have any right to claim for any regular appointment in the University/ any government organization.
- 13) The incumbent shall not have any claim (or) shall have any right for further continuation of contractual service.
- 14) Concealing of facts or canvassing in any form shall lead to disqualification of the candidature at the time of selection (or) termination even during the contractual engagement period.
- 15) Contractual engagements can be terminated at any time without prior notice or assigning any reason thereof.
- 16) The engaged persons may also leave the contractual service on their own by giving one-month notice, otherwise to be paid one-month salary before leaving.
- 17) The selected candidates will be required to undergo medical examination at their own expenses as per the rules for ensuring their physical fitness before appointment.
- 18) No TA/DA will be given to the candidates for appearing the interview.
- 19) The decision of the selection committee for the above post will be final and binding in all respects.
