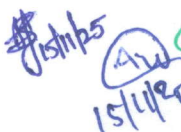

Remuneration (per month)	a) Rs.61,000/- + Applicable HRA for Master's Degree holders. b) Rs.67,000/- + Applicable HRA for Ph.D. Degree holders.
Upper Age Limit	40 years for Men 45 years for Women

B) Terms and Conditions:

- 1) The individual is engaged **purely on temporary and contractual basis** which will be terminated after completion of 11 months (or) filling of regular staff, whichever is earlier.
- 2) The incumbent shall not have any claim (or) shall have any right to claim for any regular appointment in the University/ any government organization.
- 3) The incumbent shall not have any claim (or) shall have any right for further continuation of contractual service.
- 4) Concealing of facts or canvassing in any form shall lead to disqualification of the candidature at the time of selection (or) termination even during the contractual engagement period.
- 5) Contractual engagements can be terminated at any time without prior notice or assigning any reason thereof.
- 6) The engaged persons may also leave the contractual service on their own by giving one-month notice, otherwise to be paid one-month salary before leaving.
- 7) The selected candidates will be required to undergo medical examination at their own expenses as per the rules for ensuring their physical fitness before appointment.
- 8) No TA/DA will be given to the candidates for appearing the interview.
- 9) The decision of the selection committee for the above post will be final and binding in all respects.
- 10) The Associate Dean has right to cancel or postpone the interview for the said post, for the said date due to any unavoidable circumstances/ reason thereof.
