## 1. Introduction

Andhra Pradesh Agricultural University was established on 12<sup>th</sup> June, 1964. The university was renamed as Acharya N.G. Ranga Agricultural University from 7<sup>th</sup> November, 1996 in honour of Acharya N.G. Ranga an eminent parliamentarian, farmer leader and educationist in Andhra Pradesh. ANGRAU is one of the largest State Agricultural Universities in the country with an infrastructure of 11 constituent colleges (Five in Agriculture, two in Agricultural Engineering, two in Food Science & Technology, one in Home Science, one advanced Post Graduate Centre), six affiliated agricultural colleges, 33 Research Stations spread over six Agro-Climatic Zones of the State and having strong extension linkages with 13 District Agro Advisory and Transfer of Technology Centres (DAATTCs) and 13 *Krishi Vigyan Kendras* (KVKs). #### 4. Eligibility for admission:

- i. The upper age limit is **40 years** as on 1<sup>st</sup> July of the year of admission.
- ii. Candidates seeking admission into any of the following Master's Degree and Doctoral degree courses must have passed the relevant 4 years Bachelor's Degree examination specified against each course from the A.N.G.R. Agricultural University or from any State Agricultural University (SAU) or Central Agricultural University (CAU). Candidates passed out from private Agricultural Universities/Colleges not accredited by ICAR will not be considered for admission.
- iii. For admission into Masters courses, in the qualifying examination, the candidates must have secured minimum OGPA of 6.60 / 10.00 (SC/ ST- 5.60/10.00) or 2.60 / 4.00 (SC / ST- 2.20 / 4.00) or 60% marks in traditional system (SC / ST- 50%).
- iv. For admission into Doctoral courses, Master of Science or an equivalent examination in Agriculture (or) Home Science/ (or) Agricultural Engineering, as the case may be, in the concerned field of specialisation, a minimum of 60% marks in the aggregate under traditional system of examination or an OGPA of 2.60 or above in 4.00 point scale or OGPA of 6.50 or above in 10.00 point scale in grade point system is required. In the case of SC and ST candidates, a pass in the Degree of Master of Science in Agriculture or Home Science or Agricultural Engineering as the case may be under traditional system or OGPA or 2.20 out of 4.00 or 5.50 out of 10.00 under Grade Point system is sufficient.

**5. Seat position:** No of seats available in each major field of study in **Masters** and **Ph.D.** programmes are shown in **Annexure I & II.**

**NRI / Industry Quota:** In M.B.A. (Agribusiness Management) course 10% (**2 Seats**) are reserved for NRIs / Industry Sponsored candidates. Five percent of the seats shall be provided to NRIs / and 5% to Industry sponsored candidates. If candidates of one category are not available, they shall be allotted to the other category. The candidates under NRI / Industry quota need not appear for entrance test (ICAR AIEEA (PG)-2020). They shall be selected based on merit.

**NRI Quota:** NRIs should have studied relevant bachelor degree programme prescribed against the course abroad.

**Documents needed:**

- A letter sponsoring the candidate for admission
- Attested copy of Passport with Visa details of the sponsor
- Proof for NRI (to be obtained from Indian Embassy of the respective country) or copy of the Overseas citizen of India card of the sponsor

- Note:** Resident Card / Green Card / Permanent Resident Card / Residence proof / Employment certificate are not accepted as proof of NRI
- Proof of relationship to the candidate issued in the form of Notarized Affidavit

**Industry Quota:** The candidates should possess the qualifications prescribed above and also two years relevant experience in Agribusiness Sector. They should be sponsored by the Industry / Organization.

**Documents needed:**

- Industry should be agro-based
  - Sponsorship letter
  - Photo copy of Sales Tax Registration Certificate (TNGST / CST/ GST)
  - Authorized signatory attested photocopy of PAN card of the sponsoring co-pay.
  - Self-attested photocopy of PAN card of the sponsoring company.
  - Photocopy of Audited Balance Sheet for the last three years attested by company auditor / Authorized signatory
  - Photocopy of Certificate of Incorporation
  - Documents showing that the candidate is the employee of the organization
  - Last one-year payslips of the candidate.
6. **Admission Procedure:** From the academic year 2019-20 onwards, the admission into Master's and Doctoral courses are given considering the marks / rank obtained in ICAR's All Indian Entrance Examination (AIEEA) / ICAR's All India Competitive Examination (AICE) and also previous academic performance. The student applied for a subject group has to produce rank card/marks in that subject group only. The weightage of the academic performance and AIEEA/AICE (ICAR) rank card/ marks for admission is as follows;
- For Masters Programme Admission:** The selection shall be based on the previous academic record at Under Graduate level and performance in AIEEA (ICAR) test and the weightage would be in the ratio of 30:70.
- In case of MBA (ABM), the weightage will be 30: 70 i.e., Academic (30%) and performance in AIEEA test, group discussion and interview (70%) respectively. Again, the 70% weightage is further distributed among, the AIEEA test performance, group discussion and interview as 80:10:10 duly reducing to 70 per cent.
- For Doctorial Programme Admission:** The selection shall be based on the previous academic record at Under Graduate level, Post Graduate level, AICE (ICAR) test and interview and would be in the ratio of 10:30:50:10.

**Qualifying Marks:** As per AIEEA / AICE (ICAR) rules, the candidate qualified and secured rank card/marks card in AIEEA / AICE (ICAR) are eligible for admission into Masters Degree and Doctoral Degree, respectively.

In case of a tie, the candidates who secure more marks at previous qualification shall be preferred. In case of a further tie, the marks obtained at B.Sc. level shall be considered. For further tie breaking, date of birth shall be considered and older candidates shall be preferred.



**Note:** Only women candidates are eligible for **M.Sc. & Ph.D. (Home Science)** course.

Weightage as indicated below will be given subject to a maximum of 5 marks on production of certificates for achievements in NCC/NSS/Sports/Games/Cultural/Literary activities at B.Sc. level:

**International level** - 3 marks, **Inter State Level** - 2 marks, **Inter University Level** -1 mark

### **6.1 General Instructions to applicants for admission into Masters/ Doctoral Courses: AY 2021-22**

1. **Only ONLINE application will be accepted. No application will be accepted in any other format and will be summarily rejected.**
2. The applicant should use only Chrome browsers while filling the application online.
3. The applicant has to visit the website: **www.angrau.ac.in** and do the registration.
4. The applicant should read and understand all the instructions and eligibility criteria for admission before proceeding to fill the online application form. The applicant is advised to take a print out of the instructions so that he/she can refer to the same while filling the form.
5. Important Dates:
  - Opening date of online submission of Application form: **19-11-2021 (10:00A.M.)**
  - Closing date of online submission of Application form: **02-12-2021 (11:59P.M.)**
6. The applicant should furnish all the details while filling the Online Application Form. The applicant is advised to check all the fields before submitting the form
7. In case of any submitted information has to be reviewed or edited the candidates can click on edit service in home screen and make necessary changes before making the payment
8. No Edit will be provided in any circumstances once the payment is made
9. It is the sole responsibility of the applicant to ensure that he/she fulfils the specified eligibility criteria before submitting the online application.
10. The applicant should note that the admissions will be made as per the relevant government orders applicable at the time of admission.
11. After successful submission of the application form an application reference number will be generated and this can be used for future correspondence.
12. Request for change in any particulars in the application after the payment of application fee will not be entertained.
13. The documents to be uploaded should be scanned in JPG/JPEG only and it should not exceed 1MB.
14. The scanned passport size (3.5 cm x 4.5 cm) photograph of the applicant should be in JPEG format and not exceed 100 Kb file size.
15. Documents to be scanned and uploaded:
  - SSC Memorandum of Marks or Equivalent Examination Certificate, showing the evidence of the Date of Birth.
  - Bonafide / Study Certificate from X to Degree for M.Sc. and X to Masters degree for Ph.D programme.
  - The latest certified copy of the Social Status Certificate issued by the competent authority in case of applicants belonging to Backward Classes, Scheduled Castes, Scheduled Tribes and EWS.
  - Physically Challenged Certificate. National Cadet Corps (NCC) Certificate, Sports and Games
  - Undergraduate, Post Graduate degree certificates as applicable

- ICAR AIEEA/AICE examination score card
  - Other relevant certificates.
16. **Uploading of blank pages/false/fake documents will lead to rejection of the application.**
  17. Payment of application fee: Rs.1500/- for OC&BCs (in case of SC/ST/PH applicants Rs.750/-). The applicant has to select Debit Card /Credit Card (Visa / Master Card) / NET banking option to pay the fee and follow the online instructions to complete the payment.
  18. The fee once paid will not be refunded under any circumstances.
  19. After successful submission of application and payment of fee, a PDF application will be generated with the particulars furnished by the applicant. **The same should be downloaded and hard copy along with attested photo copies of enclosures should reach to the following address on or before 08-12-2021. On the top of the envelope, it should be mentioned that “Application for admission into Masters / Ph.D programme 2021-22”.**
  20. The applicant is informed that mere submission of online application does not guarantee allotment of seat.
  21. If an applicant has been found to have furnished wrong information or deliberately suppressed any relevant information or uploaded improper documents, his/her application will be summarily rejected.
  22. The particulars furnished by the applicant in the application form are final and the applicants should therefore be very careful in uploading / submitting the application form online.
  23. The applicant should produce the originals of all the uploaded certificates for verification of the same on the counseling day.
  24. The candidate applying for PhD admission is requested to upload the Provisional Degree Certificate (PDC) or Thesis final Viva-Voce completions certificate or Thesis submission certificate issued by the concerned institute at the time of filling of the application. ***The candidates who have uploaded thesis submission certificate should submit PDC or Thesis final viva-voce certificate at the time Ph.D. interviews and he / she will not be allowed to participate in interview, if he fails to submit PDC or thesis final viva-voce certificate.***
  25. No correspondence with the applicants will be entertained.
  26. Applicants are requested to visit the University’s website: **www.angrau.ac.in** frequently for regular updates.

The merit list of eligible candidates within the subject groups will be prepared and counselling will be conducted tentatively on **Third week of December, 2021**. The candidates are advised to visit the University website for regular updates. The selected candidates shall submit the necessary certificates in original and pay the prescribed fee and secure the admission at the allotted colleges. Failure to do so entails forfeiture of claim for seat. For Doctoral degree programmes, seats will be filled and displayed after preparation of merit list within the subject groups duly following the regional, social and rule of reservation as per Government Orders. The date of registration will be intimated in due course of time. Candidates are advised to visit the University website for Latest Updates.

## 7. Rule of reservations:

### A. Reservation of seats in favour of Local/Non Local candidates:

(In accordance with the A.P Educational Institutions (Regulation of Admissions) Order, 1974.)

- (i) After bifurcation of the A.P State, a new University for the Telangana State was formed as professor Jayashankar Telangana State Agricultural University (PJ TSAU). The total no. of seats approved for the combined University ANGRAU were divided in the ratio of 64% (42% for AU, 22% SVU) and 36% (for OU) for ANGRAU and PJ TSAU, respectively duly following the provisions under the article 371D. Admission to 85% of the seats shall be reserved in favour of and allocated among the **local candidates** in relation to the local area in respect of the **Andhra University, Nagarjuna University and Sri Venkateswara University** in the ratio of 42:22 respectively.
- (ii) Among the seats allotted to respective states, the local seats (85%) will be filled by the respective Universities of the respective States through their admission procedure. The remaining 15% of unreserved (non-local) seats of respective Universities will be filled in open competition.
- (iii) While determining the number of seats to be reserved in favour of the local candidates under Sub-Para (i) any fraction of a seat shall be counted as one provided that there shall be at least one unreserved seat.
- (iv) While allocating under Sub-Para (i) the reserved seats among the local candidates in relation to the different local areas, fraction of a seat shall be adjusted by counting the greatest fraction as one and if necessary also the greater of the remaining fractions as another, and where the fraction to be so counted cannot be selected by reason of the fractions being equal, the selection shall be by lot, provided that there shall be at least one seat allocated for local candidates in respect of each local area.
- (v) If a local candidate in respect of a local area is not available to fill any seat reserved or allocated in favour of a local candidate in respect of local area, such seat shall be filled as if it had not been reserved.

#### Local Candidates:

1. A candidate for admission to any course of study shall be regarded as a local candidate in relation to a local area:
  - a) If he has studied in an educational institution or educational institutions in such local area for a period of not less than four consecutive academic years ending with the academic year in which he appeared, or as the case may be, first appeared in the relevant qualifying examination: **OR**
  - b) Where, during the whole or any part of the four consecutive academic years ending with the academic year in which he appeared or, as the case may be, first appeared for the relevant qualifying examination, he has not studied in any educational institution, if he has resided in that local area for a period of not less than four years immediately preceding the date of commencement of the relevant qualifying examination in which he appeared or, as the case may be, first appeared.

2. A candidate for admission to any course of study who is not regarded as a local candidate under sub-paragraph (1) in relation to any local area shall:
- a) If he has studied in educational institutions in the State for a period of not less than seven consecutive academic years ending with the academic year in which he appeared or, as the case maybe, first appeared for the relevant qualifying examination be regarded as a local candidate in relation to;
- i) Such local area where he has studied for the maximum period out of the said period of seven years;  
**OR**
- ii) Where the periods of his study in two or more local areas are equal, such local area where he has studied last in such equal periods:  
**OR**
- b) If, during the whole or any part of the seven consecutive academic years ending with the academic year in which he appeared or as the case may be, first appeared for the relevant qualifying examination, he has not studied in the educational institutions in any local area, but has resided in the State during the whole of the said period of seven years, be regarded as a local candidate in relation to:
- i) Such local area where he has resided for the maximum period out of the said period of seven years;  
**OR**
- ii) Where the periods of his residence in two or more local areas are equal, such local area where he has resided last in such equal periods.

**Explanation:** For the purpose of this paragraph.

- i) "Educational Institution" means a University or any educational institutions recognised by the State Government or a University or other competent authority;
- ii) "Relevant Qualifying Examination" in relation to admission to any course of study, means the examination a pass in which is minimum educational qualification of admission to such course of study;
- iii) In reckoning the consecutive academic years during which a candidate has studied, any period of interruption of his study by reason of his failure to pass any examination shall be disregarded. Any period of his study in a State wide University or a State-wide Educational Institution shall also be disregarded;
- iv) The question whether any candidate for admission to any course of study has resided in any local area shall be determined with reference to the places where the candidate actually resided and not with reference to the residence of his parent or other guardian.

### **3. LOCAL STATUS OF STUDENTS MIGRATED FROM TELANGANA TO ANDHRA PRADESH**

As per the G.O.Ms.No.132 & 132 GA, dated 13.06.2020 & G.O.Ms. No. 171, dated 20-11-2017 of the General Administration (SPF&MC) Department, it is stated that:

#### 10. General Information:

b. ***If a particular course is offered in more than one college, allotment of students to a college shall be based on preference of the student and availability of the seats in the respective college.*** PG students should necessarily complete the PG programme in the college where they join. However, they can conduct the research work elsewhere with the prior permission of the University.

c.

i. PG students should not register for any other degree/diploma programme concurrently on regular or part-time basis either in this University or in any other University/Educational Institution.

ii. Those who joined M.Sc. in ANGRAU but could not complete the requirement or withdrawn from M.Sc. courses in ANGRAU for not maintaining minimum OGPA and apply again shall appear for Entrance Test and seek admission afresh. However, stipend if any paid earlier shall be recovered in full.

iii. Those who completed M.Sc. in one discipline and apply for admission into a different discipline shall not be considered for admission.

d. All admissions shall be deemed as provisional and subject to further scrutiny. The admission shall be liable for cancellation without notice at any stage during the study of the students if it is found that this admission is in any way repugnant to the rules/regulations or invalid by reason of incorrect or false information furnished by the applicants or their parents/guardians at the time of admission. Any cancellation of admission shall not exclude penal action under the relevant criminal law.

e. The University reserves to itself the right to cancel or vary any of these rules without notice.

Note: The candidates shall note that the admissions will be made as per the relevant Government orders applicable at the time of admissions. Payment of stipend is subject to the guidelines issued by the Government from time to time.
