The applications should be supported with full documents relating to the outstanding Research work carried out by the individual in the last five years i.e., from 2016-17 to 2020-21 ending on 31.03.2021 for the gold medal to be awarded for 2020-21 and from 2017-18 to 2021-22 ending on 31.03.2022 for the gold medal to be awarded for 2021-22.

The Scientists who have received this award in the last five years are not eligible for the award.

The applications in quadruplicate with all enclosures super scribed as "Application for award of "Smt. EDARA SUBBAYAMMA and Sri EDARA VENKATA RAO GOLD MEDAL" in Agricultural Sciences in A.P. for the year 2020-21" and with same superscription for 2021-22 separately (separate application for 2020-21 and 2021-22) should reach this Office on or before **20.04.2023** positively.

The applications which do not comply with the above instructions will be summarily rejected.

All the Heads of the Offices noted in the address entry are requested to give vide publicity about the award among the researchers of all the categories of Scientists under their control and call for the applications.

# GUIDELINES FOR THE AWARD OF SMT. EDARA SUBBAYAMMA AND SRI EDARA VENKATA RAO MEMORIAL GOLD MEDAL WITH CITATION FOR THE BEST SCIENTIST IN AGRICULTURAL SCIENCES

- Scientists/Teachers/Extension Workers in the cadre of Assistant Professors, Associate Professors and Professors are eligible for Award.
- Research Scientists who are presently working in Teaching/Extension but have put in 5 years in Research during the preceding 7 years are also eligible for the award.
- 3. This award will be presented to the Best Scientist in Agricultural Sciences every year during the Annual Convocation of the University.
- 4. This award will not be given in a particular year if suitable Research Scientists are not available. The award will also lapse and will not be carried to subsequent years.
- 5. The Award consists of Gold Medal and Citation.

### 6. Procedure for selection:

- The Research Scientists themselves through their Heads of Office may submit application.
- The Heads of the Research Stations/Colleges/Extension Units may nominate Scientists for the award.
- iii. In respect of Research Scientist presently working in teaching/extension, they may send their applications through the concerned Heads under whom they worked.

A Committee consisting of the Associate Director of Research with 2 Senior Officers and one of the Unit Head of Extension center may be constituted to screen the applications received for consideration of the award at each Regional Agricultural Research Station. All the applications received along with recommended list of candidates by the Committee may be forwarded to the University.

7. While considering the applications, weightage will be given as follows:-

#### RESEARCH

a) Research contributions as judged by their innovative nature, popularity and adoption by farmer and also contribution to basic research.

b) Original Research papers published.

c) Review articles published

d) Papers presented in National & International Conferences Seminars and Symposia

- e) Books/Manuals prepared and accepted for Teaching/Research/Extension and training programmes.
- f) Experience in planning of Research Project.
- A Committee appointed by the Vice-Chancellor will evaluate the applications/nominations received, keeping in view of the weightage as mentioned above and send their recommendations to the Vice-Chancellor for consideration and approval.
- 9. There should be at least 5 years of gap between two awards for the same teacher.
- 10. University reserves the right to select or not any teacher from a discipline.
