Instructions to Candidates

The eligible candidates applied are requested to attend the manual counselling (attend in-person) on **18-08-2026 at 9:30A.M. in Krishna Auditorium, Regional Agricultural Research Station, Lam Farm (Amaravati Road), Lam, Guntur – 522 034**. The candidate who secures a seat shall pay the prescribed fee at the time of counseling in the form of cash as detailed below.

Note: Fee once paid will not be refunded. In case, if any student desires to cancel his/her after admission then seat cancellation fee has to be paid in excess.

1. The following certificates in Original shall be produced at the time of manual counseling.

- Two conduct certificates one from the College or School where the candidate last studied and the other from an officer of the State Government or any other respectable person.
 - Transfer Certificate from the College or School where the candidate last studied.
 - Pass Certificate cum Memorandum of Marks obtained by the candidates in the qualifying examination
 - The Community Certificate in the case of candidates belonging to Backward Classes, Scheduled Castes and Scheduled Tribes, signed by the competent authority.
 - In case of PH (Differently Abled) candidates, a valid disability certificate.
 - For EWS category, a valid EWS certificate
 - Farmers Quota Certificates - Form I and Form II : 2026-27 – Issued by competent authority
 - Three passport size photographs.
 - An Income Certificate of father / mother signed by any Officer not below the rank of the Mandal Revenue Officer of the Revenue Department of the Mandal concerned.
 - Physical fitness certificate issued by a Govt. Doctor not below the rank of Assistant Civil Surgeon.
- The provisional list of NCC/Sports/ Physically Handicapped (Differently Abled) / Defense Personal will be verified.
 - The candidature of all applicants in the entire admission process is “PURELY PROVISIONAL” pending scrutiny of eligibility as per the Information Brochure.
 - In case, it is found at any stage of admission that the applicant does not fulfill the eligibility criteria and any information/document provided by the applicant is found to be false or is not in conformity with the eligibility criteria mentioned in the Information Brochure AY– 2026-27 including Age, Caste Category, Sub-Category, Educational Qualification, etc. the candidature of such applicant will summarily be rejected at any stage of admission process and even after admissions.
