TERMS & CONDITIONS

- 1. The successful tenderer shall abide by the terms and conditions as stipulated Agricultural Research Station, Amadalavalasa hereinafter called as "ARS, Amadalavalasa" from time to time.
- 2. All precautions, conditions, Rules and Regulations to be followed at ANGRAU, Admn. Office, Guntur will be given in writing/oral by the Agricultural Research Station, Amadalavalasa.
- 3. The Work on Contract shall be for 180 days (one season (i.e. Kharif/Rabi), from the date of assumption of charge and shall terminate at any time without any notice.
- 4. The valid registration shall cover the entire period of contract.
- 5. Taxes if any to be paid to the Government of Andhra Pradesh/Govt. of India as the case may be are to be borne by the Agency only.
- 6. In case of any accident or any injury sustained by any workmen engaged in the performance of the work relating to the contract, all expenditure shall be borne by the Agency/Firm and the Agricultural Research Station, Amadalavalasa will not undertake any responsibility on this.
- 7. No conditional tender will be accepted.
- 8. The Agency/Firm having any relatives working in the Agricultural Research Station, Amadalavalasa at any level can not submit tenders.
- 9. Bank statements for the last 2 years have to be furnished.
- 10. The successful tenderer shall abide by the terms and conditions as stipulated by the Agricultural Research Station, Amadalavalasa from time to time.
- 11. The successful tenderer shall furnish an indemnity bond.
- 12. The Scientist(Entomology) &Head, Agricultural Research Station, Amadalavalasa will have every right to increase or decrease the strength of the Security Points as per the requirement from time to time and the successful tenderer shall not have any objections for such demand from the Agricultural Research Station, Amadalavalasa.

In the event of any question, dispute or difference arising under these conditions or any conditions contained in the Work Order or in connection with this contract, the same shall be referred to the sole arbitration of the ANGRAU, Agricultural Research Station, Amadalavalasa or some other person appointed by it. The award of the arbitrator shall be final and binding on the parties to this contract.
- 19. The University reserves the right to forfeit the EMD of Agency on account of premature withdrawal from the tenderer. The decision of the Senior Scientist(Entomology) & Head of the Agricultural Research Station, Amadalavalasa shall be final in this regard.
- 20. The Agency shall not claim any amount more than the amount fixed by way of agreement by the competent authority.
- 21. The Agency will have to ensure satisfactory standards of its employee competence, conduct, cleanliness and integrity. Neglect of duties, undesirable act, misbehavior and consumption of alcohol while in duty etc., shall be viewed seriously.
- 22. The Agency shall not transfer or assign sub-contract to any other party.
- 23. This Institute shall not be liable to pay and allowance, salary or any other amount under any law in force for the staff engaged by the Agency. The Agricultural Research Station, Amadalavalasa shall also not liable for breach of any OPERATIONS laws or any other laws in force by the Agency or the persons deployed on duty. The Agency to whom the contract is given will not be entitled to any other allowances or benefits which are not included.
- 24. This Institute shall not be liable for any illegal action or omission made by the staff of the Agency. In case of any loss of damage to the Agricultural Research Station, Amadalavalasa on account of any act, omission, negligence on the part of the Agency and or its representative etc., in handling of the duties/functions entrusted or otherwise or on account of breach, omission, failure or negligence on the part of the agency or it's agents/representatives in the compliance of provisions thereof or in carrying out, executing, doing, performing or fulfilling any of its obligations or operations hereunder, the Agency shall be liable to make, good such loss or damage determined by the Agricultural Research Station, Amadalavalasa and shall not be open to any question by the Agency.
- 25. Once a Bid approved by the Undersigned, there is no changes in financial commitments during the financial year 2025-26.
- 26. The Agricultural Research Station, Amadalavalasa may recover such, amount or loss of damage from the Agency's bills which may become due and payable to the Agency in terms thereof from the Agricultural Research Station, Amadalavalasa. If the amount of such loss or damage is not recovered or paid by the Agency forthwith on demand, the Agency shall be liable to pay the said amount with interest @ 18% per annum thereon from the date of demand till the date of actual payment.
- 27. The Agency is required to comply with all the legal liabilities and if the Agency is found failing to comply the provisions of various acts applicable, the Agricultural Research Station, Amadalavalasa can ask for the records for inspection and the Agency is required to

comply with all the liabilities to be discharged and in case of any failure on the part of the Agency, the Agricultural Research Station, Amadalavalasashall withhold payment of its bill.

- 28. The terms and conditions of this tender shall be part and parcel of the Agreement to be executed by the person or institution whose tender is accepted.

In case, the Agency or it's workers are allowed to work at the premises of the Agricultural Research Station, Amadalavalasa, the Agency will have no right or lien whatsoever upon the premises and the Agency and it's workers will move out of the premises at instance of the Agricultural Research Station, Amadalavalasa.
- 33. The Agricultural Research Station, Amadalavalasa will not in any manner be responsible for any act, omission or commission of the workers engaged by the Agency and no claim in this respect will lie against the Agricultural Research Station, Amadalavalasa. If any such claim is made against the Agricultural Research Station, Amadalavalasa by any worker or his heirs engaged/employed by the Agency, which the Agricultural Research Station, Amadalavalasa is obliged to discharge by virtue of any statute or any provision of law and rules due to mere fact of the workers of the Agency working at the Regional Agricultural Research Station, Lam premises or otherwise, the Agency will be liable to indemnify/reimburse to the Agricultural Research Station, Amadalavalasa all the memory paid in addition to the expenses incurred by him/her.
- 34. The Agreement be terminated even before the stipulated period by either party by giving the other one months notice in writing.
- 35. List of records to be maintained by the Agency for operations in the Agricultural Research Station, Amadalavalasa farm should be produced to the Agricultural Research Station, Amadalavalasa. These records are subject to scrutiny/inspection by the authorized officers of the Agricultural Research Station, Amadalavalasa.
- 36. The Agricultural Research Station, Amadalavalasa reserves the right to terminate the contract after giving notice in case of breach of any terms and conditions of the tender.
