Applications are invited from eligible *in-service teachers of ANGRAU* for admission into Ph.D. programmes under the **In-Service Quota** for the Academic Year 2025–26. Candidates must have completed a minimum of **three years of regular service** with confirmed probation.

Note: In the event of no applications for a particular subject, the seats will be reallocated to other disciplines/faculties and offered to eligible candidates.

Eligibility Conditions

Educational Qualifications

- **General Candidates:** Master's degree in the relevant faculty and major field with **minimum 50% marks** in the traditional system or an **OGPA of 7.50/10.00 or 3.25/4.00**.
- **SC/ST Candidates:** Minimum pass marks in the traditional system or an **OGPA of 7.00/10.00 or 3.00/4.00**.
- A basic degree in the relevant faculty is essential.
- Teachers of ANGRAU with an **M.Sc. in pure sciences** are also eligible, provided they have completed at least **10 years of regular service in ANGRAU** in the relevant subject.

Service Requirement

- Minimum of **3 years of regular service** with probation confirmed.
- Eligible candidates will be permitted to pursue two semesters with full pay and allowances.

Age Limit

- Maximum age **47 years as on 01.07.2025**.
- Relaxation of **5 years** for Women, SC, ST, and Persons with Benchmark Disabilities (PwBD).

Reservation of Seats

- Scheduled Castes (SC): **15%**
 - SC Group I: 1%
 - SC Group II: 6.5%
 - SC Group III: 7.5%
- Scheduled Tribes (ST): **6%**
- Backward Classes (BC): **29%**
- BC-A: 7% BC-B: 10% BC-C: 1% BC-D: 7% BC-E: 4%
- Persons with Disabilities (PwD): **5%** (as per Government norms).

Criteria for Selection

Selection will be based on the following:

1. Academic qualifications
2. Length of regular service in ANGRAU
3. Service in *remote areas* of ANGRAU
4. Research publications and professional achievements
5. Performance in interview

- The envelope should be superscribed as “**Application for Ph.D. Admission 2025–26 – In-Service Quota.**”
- Advance copies of applications and enclosures may be sent directly to the Registrar to avoid postal delays.
- The endorsement by the Head of Office on the application form will suffice; **a separate covering letter is not required.**
- Heads of Institutes/Offices are requested to **circulate this notification widely, display it on notice boards, and ensure timely forwarding of applications.**

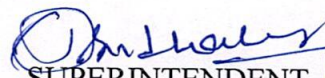
