#### 1. Introduction:

The Andhra Pradesh Agricultural University was established on 12th June, 1964. In recognition of the remarkable contributions of Acharya N.G. Ranga, an eminent parliamentarian, farmer leader, and educationist, it was renamed as Acharya N.G. Ranga Agricultural University (ANGRAU) on 7th November, 1996.

Today, ANGRAU stands as one of the **largest State Agricultural Universities (SAUs) in India**, with a robust infrastructure that includes:

#### 4. Eligibility for admission:

1. The upper age limit for admission shall be 40 years as on 1st July of the admission year.

2.

- i. Candidates applying for admission into the aforementioned Master's and Doctoral degree programmes must have successfully completed the relevant four-year Bachelor's degree in the respective discipline.
  - a. examination specified against each course from ICAR Accredited Agricultural University/ agricultural colleges affiliated to accredited university.
  - b. Candidates passed out from private & deemed Agricultural Universities/ private Agricultural Colleges which are not accredited by ICAR will not be considered for PG/Ph.D. Regular Admissions in ANGRAU.
- ii. For admission into Masters courses, in the qualifying examination, the candidates must have secured minimum OGPA of 6.60 / 10.00 (SC/ST- 5.60/10.00) or 2.60 / 4.00 (SC / ST-2.20 / 4.00) or 60% marks in traditional system (SC / ST-50%).
- iii. For admission into Doctoral courses, in the qualifying examination, the candidates must have secured minimum OGPA of 6.50 / 10.00 (SC/ ST- 5.50/10.00) or 2.60 / 4.00 (SC / ST-2.20 / 4.00) or 60% marks in traditional system (SC / ST- 50%)

5. **Seat position:** No of seats available in each major field of study in **Masters** and **Ph.D.** programmes are shown in **Annexure I & II** respectively.

6. **Admission Procedure:** From the academic year 2019-20 onwards, the admission into Master's and Doctoral courses are given considering the score / rank obtained in ICAR's All Indian Entrance Examination (AIEEA) / ICAR's All India Competitive Examination (AICE) and also previous academic performance. The student applied for a subject group has to **produce rank card/marks in that subject group only**. The weightage of the academic performance and AIEEA/AICE (ICAR) rank card/ marks for admission is as follows:

For Masters Programme Admission: The selection shall be based on the previous academic record at Under Graduate level and performance in AIEEA (ICAR) test and the weightage would be in the ratio of 30:70. In the case of MBA (AB) as well, the same weightage will be applied, i.e., 30:70 — with 30% for Academic performance and 70% for performance in the AIEEA test.

**For Doctorial Programme Admission**: The selection shall be based on the previous academic record at Under Graduate level, Post Graduate level, AICE (ICAR) test performance and interview and would be in the ratio of 10:30:50:10 respectively.

Qualifying Marks: As per AIEEA / AICE (ICAR) rules, the candidate qualified and secured score card / rank card in AIEEA / AICE (ICAR) are eligible for admission into Masters Degree and Doctoral Degree, respectively.

In case of a tie, the candidates who secure more marks at previous qualification shall be preferred. In case of a further tie, the marks obtained at B.Sc. level shall be considered. For further tie breaking, date of birth shall be considered and older candidates shall be preferred.

#### **NCC - Weightage:**

An NCC candidate shall be entitled to avail the benefit of reservation under the NCC **quota only once in their lifetime**. In other words, an NCC cadet may secure admission under this category into a **Diploma**, **Undergraduate**, **or Postgraduate programme** only on a single occasion.

The **allotment of seats** under this category shall be carried out strictly in accordance with the provisions of the Higher Education (RM) Department, Government of Andhra **Pradesh - G.O.Ms.No.43, dated 16-07-2025**, relating to the admission of NCC cadets into Diploma, Undergraduate, and Postgraduate courses.

#### NSS/Sports/Games/Cultural/Literary activities - Weightage:

A maximum of 5 marks shall be awarded for achievements in NCC, NSS, Sports & Games, Cultural, or Literary activities at the B.Sc. level, subject to the submission of valid supporting certificates. The distribution of marks will be as follows:

**International Level –** 3 marks Inter-State Level - 2 marks **Inter-University Level** – 1 mark

1. Mode of Application

- Only online applications will be accepted. Applications submitted in any other format will be summarily rejected.
- Applicants are advised to use the Google Chrome browser while filling the online application form.

#### 2. Registration and Guidelines

- Applicants must visit the University website: <a href="www.angrau.ac.in">www.angrau.ac.in</a> and complete the registration process.
- Candidates should carefully read and understand all instructions and eligibility criteria before proceeding to fill the application form.
- It is advisable to take a printout of the instructions for ready reference while filling the form.

#### 3. Important Dates

- Opening date for online submission of application: **03-09-2025** (**10:00 AM**)
- Closing date for online submission of application: 18-10-2025 (11:59 PM)
- Last date for receipt of hard copy of the application with enclosures: **22-10-2025**

#### 4. Filling and Editing of Application

- Applicants must furnish all details carefully while filling the online application.
- Before submission, applicants are advised to review all fields.
- If any detail requires modification, applicants may use the 'Edit Service' option available on the home screen before making payment.
- No editing facility will be available once the application fee has been paid.

#### 5. Eligibility Responsibility

- It is the sole responsibility of the applicant to ensure that they meet the prescribed eligibility criteria before submission of the application.
- Admissions will be made in accordance with the relevant Government Orders in force at the time of admission.

#### 6. Application Reference Number

• On successful submission, an application reference number will be generated. This should be quoted in all future correspondence.

#### 7. Document Upload

- All documents must be scanned and uploaded in JPG/JPEG format. Each file should not exceed 1 MB.

#### 8. Application Fee

- Rs. 1,500/- for OC & BC candidates
- Rs. 750/- for SC/ST/Differently-abled candidates

• Payment must be made through Debit Card / Credit Card (Visa/MasterCard) / Net Banking by following the online instructions.

#### 9. Submission of Hard Copy

- After successful submission of the application and fee payment, a PDF copy of the filled application will be generated.
- Applicants must download, take a printout, and send the hard copy along with attested photocopies of all enclosures to the specified address on or before 22-10-2025.
- The envelope should be super scribed with: "Application for Admission into Master's / Ph.D. Programme 2025-26".

#### 10. Verification and Admission Process

- Mere submission of the application does not guarantee admission.
- Applications found with incorrect/false information or improper documents will be rejected.
- All particulars furnished in the application will be treated as final; applicants must therefore exercise utmost care.
- Original certificates must be produced at the time of counselling for verification.

#### Additional Requirement for Ph.D. Applicants:

- Candidates must upload a Provisional Degree Certificate (PDC) or Thesis Final Viva-Voce Completion Certificate or Thesis Submission Certificate at the time of application.
- Candidates submitting a Thesis Submission Certificate must produce the PDC / Final Viva-Voce Certificate at the time of Ph.D. interviews. Failure to do so will result in disqualification from the interview.

#### 11. Counselling and Seat Allotment

- The merit list of eligible candidates within subject groups will be prepared and counselling is tentatively scheduled in the last week of October, 2025.
- Selected candidates must produce original certificates, pay the prescribed fee, and secure admission at the allotted colleges. Failure to do so will result in forfeiture of the seat.
- For Doctoral programmes, seats will be filled and displayed after preparation of subject-wise merit lists, duly following regional, social, and rule of reservation policies as per Government Orders.
- The date of registration will be announced in due course.

#### 12. General Instructions

- Requests for changes in application details after fee payment will not be entertained.
- No correspondence with applicants will be entertained.
- Applicants must visit the University website (<u>www.angrau.ac.in</u>) regularly for updates.
- 7. **Reservation of Seats:** (In accordance with the Higher Education (EC) Department Comprehensive amendments for reservation in admission in Educational Institutions in the State G.O.Ms.No.20, dated 12-05-2025)
  - 1. The **State of Andhra Pradesh** was bifurcated into the **State of Telangana** and the **State of Andhra Pradesh** through the *Andhra Pradesh Reorganization Act, 2014 (Act No. 6 of 2014)*.

- 2. As per **Section 95** of the said Act, the existing admission quotas in all Government and Private institutions, whether aided or unaided, for **Higher and Technical Education**, governed by **Article 371-D of the Constitution of India**, were to continue for a period of **ten years** from the *appointed day of bifurcation*, during which the **common admission process** was to be followed.
- 3. The said ten-year period, commencing from **2nd June 2014**, came to an end on **2nd June 2024**. Consequently, the **common admission process** under Section 95 has ceased to be in force.
- 4. Now, therefore, in exercise of the powers conferred under Sections 3, 3-A, 4 and 15 of the Andhra Pradesh Educational Institutions (Regulation of Admission and Prohibition of Capitation Fee) Act, 1983 (Act No. 5 of 1983), the Government of Andhra Pradesh hereby makes the following amendments to the existing Admission Rules relating to Postgraduate and Ph.D. Courses (Regular / Lateral Entry), which shall come into effect from the Academic Year 2025-26 onwards.

#### A. Distribution of Seats

- 85% of the available seats shall be reserved exclusively for local candidates of Andhra Pradesh.
- The remaining 15% of unreserved seats shall be filled on an open competition basis, and are open to both local and non-local candidates.

#### **B. Category-wise Reservation**

- Backward Classes (BC): 29%
  - BC-A: 7%
  - BC-B: 10%
  - BC-C: 1%
  - BC-D: 7%
  - BC-E: 4%
- Scheduled Caste (SC): 15%
  - Group I: 1%
  - Group II: 6.5%
  - Group III: 7.5%
- Scheduled Tribe (ST): 6%
- **Differently Abled Candidates:** 3% seats as per Government norms.
- NCC: 1% of seats
- **Economically Weaker Sections (EWS):** 10% (supernumerary seats) for candidates other than SC, ST & BC.

#### C. Allocation of Local Seats

Of the **85% local seats**, the distribution among local areas shall be as follows:

- Andhra University Region: 65.62%
- Sri Venkateswara University Region: 34.38%

#### D. Eligibility for the 15% Unreserved Seats

The following categories of candidates are eligible for admission under the **15% unreserved quota**:

- Candidates who qualify as **local candidates** in both local areas of Andhra Pradesh.
- Candidates who have **resided in the State for a total of 10 years**, excluding periods of study outside the State, or whose **parents have resided in the State for 10 years**, excluding periods of employment outside the State.
- Candidates who are **children of employees** of the State Government, Central Government, Public Sector Corporations, Local Bodies, Universities, or other similar quasi-public institutions within the State.
- Candidates who are **spouses** of those employed in the above-mentioned categories within the State.

#### Note:

• "State" means Andhra Pradesh.

For candidates who have obtained their B.Sc. (Ag.) / B.Sc. (Hort.) / B.Sc. (Home Science) / B.Tech. (Dairying) / B.Sc. (Dairy Technology) / B.V.Sc. degrees from Acharya N.G. Ranga Agricultural University (formerly Andhra Pradesh Agricultural University), only the period of study prior to admission into the University shall be taken into account for determining their Local / Non-Local status.

#### 8. Application & Enclosures:

- i. Candidates shall submit their applications **only through the online mode**. The link for the online application will be available on the University website: www.angrau.ac.in. Applicants are advised to **carefully read the guidelines** before filling in the application form and ensure that all **required documents** are uploaded as specified.
- ii. A hard copy of the duly filled-in online application (downloaded form), along with attested photocopies of all enclosures, must be sent to the address given below so as to reach on or before 22-10-2025 by 4:00 PM.
- iii. On the top of the envelope, the applicant must clearly superscribe: "Application for Admission into Master's / Ph.D. Programme 2025-26".

  - Candidates who pursued continuous study in recognised educational institutions must enclose Study Certificates. In such cases, Residence Certificates will not be accepted.
  - Candidates who had a break in study for reasons other than failure, or those who passed the qualifying examination through private study, must submit a **Residence Certificate** in the prescribed format (Annexure IV).
- f) Social Status Certificate issued by the competent authority, in case of candidates belonging to BC / SC / ST categories. Admission under this quota shall remain provisional until the claim is verified and confirmed by the respective Government Directorate.
- g) Certificates of achievements at the B.Sc. level in NCC / NSS / Sports / Games / Cultural / Literary activities at International / Inter-State / Inter-University level, if applicable.
- h) Date of Birth Certificate.
- i) Certificate of Disability (if applicable).

#### Additional Documents to be Submitted at the Time of Admission (in Original)

Candidates provisionally selected for admission must produce the following original documents at the time of admission, in addition to the originals of the above certificates:

- i. Migration Certificate, if the candidate has passed the qualifying degree from a University other than ANGRAU.
- ii. Transfer Certificate from the College / Institution last attended.

#### 9. Application Fee:

The application fee is fixed at Rs. 1,500/- for candidates belonging to the General (OC and BC) categories, and Rs. 750/- for candidates belonging to SC/ST categories and differently-abled candidates

#### 10. General Information:

#### a. Financial Assistance

The University does not provide any financial assistance directly to postgraduate students. However, students may avail themselves of stipends, scholarships, or long-term educational loans, if offered by the Government or other external agencies, subject to the terms and conditions prescribed by the respective agencies.

#### b. College Allotment and Research Work

If a particular programme is offered in more than one college, allotment of students shall be made based on the student's preference and the availability of seats in the respective college. Students admitted to a particular college must necessarily complete their programme in that college. However, with the prior approval of the University, research work may be undertaken at another location or institution.

#### c. Academic Restrictions

i. Postgraduate students shall not register simultaneously for any other degree or diploma programme, either on a regular or part-time basis, in this or any other University/Educational Institution.

- ii. Candidates who were previously admitted to M.Sc. programmes in ANGRAU but failed to complete the requirements or withdrew due to non-maintenance of the prescribed minimum OGPA, and who wish to re-apply, must appear for the Entrance Test and seek admission afresh. Any stipend received earlier shall be recovered in full.
- iii. Candidates who have already completed an M.Sc. in one discipline shall not be considered for admission into another discipline.

#### d. Provisional Nature of Admission

i. All admissions shall be treated as purely provisional and subject to further verification. Admission may be cancelled at any stage of study, without prior notice, if it is found to be contrary to rules and regulations, or based on incorrect, false, or misleading information furnished by the applicant or their parents/guardians at the time of admission. Such cancellation of admission shall not preclude penal action under relevant criminal law.

#### e. University's Right to Amend Rules

i. The University reserves the right to modify, amend, or cancel any of the rules and regulations without prior notice.

**Note:** Admissions will be made in accordance with the Government orders in force at the time of admission. The payment of stipends, wherever applicable, shall be subject to Government guidelines issued from time to time.
