Sub: ANGRAU – Award in the name of Acharya N.G.Ranga – Institution of Young Scientist Award – Formulation of Guidelines and criteria – Orders – Issued.

The University has proposed to institute a Young Scientist Award in the name of Acharya N.G.Ranga to commemorate his birth centenary. A Committee was constituted with Deans of faculties and the Directors for formulation of guidelines and modalities. The committee met on 28-10-2000 and formulated the guidelines for this award. The Committee decided to name the Award as “Acharya N.G.Ranga Young Scientist Award”. The sponsors of the Award is the ANGR Agricultural University.

The Academic Council at its meeting held on 31-10-2000 has unanimously resolved vide resolution No.1957 to institute a Young Scientist Award consisting of a cash prize of Rs.10,000/- and a Gold Medal and citation to commemorate the birth centenary celebrations of Acharya N.G.Ranga and also approved the selection criteria for this award.

(a) Eligibility criteria

- (i)** The objectives of the award is to recognize original research work done by the Young Scientist and to provide incentives to young scientists for carrying on their research work. The award also will promote high quality research in Agriculture and allied areas.
- (ii)** The award is exclusively meant for individual Young Scientists and one award will be given every year at the Annual Convocation of the University.
- (iii)** *Scientists below the age of 38 years of age (as on 31st Dec., of the year) who hold a regular teaching, research or extension job in the University are eligible to compete for the Award.
- (iv)** Scientists should have engaged themselves in research in the concerned subject area for atleast five years continuously before the last date of applications for the award.
- (v)** Scientists working in the areas of Agriculture and allied sciences including Horticulture, Veterinary Science, Dairy Science, Fisheries Science, and Home Science including women's studies are eligible.

(b) Administration of the Award:

The award will be administered by the Registrar, Acharya N.G.Ranga Agricultural University. There shall be a Judging Committee consisting of 3 eminent academicians including Chairperson appointed by the Vice-Chancellor, ANGRAU. The work done reports and Bio-data of the persons who apply for the Award will be forwarded to the members of the Judging Committee will evaluate the applications and identify outstanding Young Scientists and make recommendations to the Vice-Chancellor.

(c) Previous research work done excluding the research work conducted for Masters/Doctoral Degrees

Research Projects/Programmes in which participated.

Level of participation in each project/Programme as Leader/Associate.

Specific objectives and originality to the research projects.

Impact of research work on productivity/socio-economic significance.

Publications emanating out of the research work

Further programmes of research proposed by the candidate and their expected symposia.

Nominations for the Award will be invited during September/October of each year. The prospective applicants have to obtain the prescribed programme from the Registrar, ANGRAU and submit their applications before the deadline prescribed. The applications will be forwarded to the Judging Committee for screening, which will forward its recommendations to the Registrar. No award will be given if in the opinion of the Judging Committee none of the applications are qualify for the award in any particular year.

(d) Presentation of the Award:

The Award consisting of a Cash Prize of Rs.10,000/-, a Gold Medal and a Citation will be presented to the selected scientists at the Annual Convocation of ANGRAU.

These orders will come into operation with immediate effect.
