At the verge of completion of Golden Jubilee Year of the ANGRAU, presently located at Lam, Guntur, Andhra Pradesh, India. it has given birth to a new State Agricultural University of Telangana namely Prof. Jayashankar Telangana State Agricultural University with the bifurcation of the state of Andhra Pradesh as per the Andhra Pradesh Reorganization Act 2014. The ANGRAU at LAM, Guntur is serving the students and the farmers of 26 districts of new State of Andhra Pradesh with renewed interest and dedication.

First you must apply by sending a mail with the admission form duly filled along with medical certificate and all other certificates of educational qualification to the mail : rptoangrau2022@gmail.com & a copy of Whatsapp to the APSARA Office Number : 6300548489. Only after admission form is received by us, we will attend the calls.**
- 2. 10+2 / Agricultural Diploma or equivalent course of 2 years duration and above**
- 3. Indian Valid Passport**
- 4. Valid Indian Passport is a must to attend the training programmes. Applying with wrong details will amount to cancellation of admission and certification at any stage.*
- 5. Fee must be paid only upon confirmation of the admission to the applicant. Pre –Payment doesnot entitle the admission in any way. The fee must be paid well in advance (2-5 days) before reaching the Training Centre after confirmation of the admission from ANGRAU.*
- 6. No refund of the fees shall be made in case of withdrawal of admission by the candidate for any reason. All original documents and Photographs are to be carried while reporting for training.*
