They are advised to refer the problems / complaints of woman employees to the University level committee constituted through audio or video clippings or photographs or other way of proofs if available for which problems / complaints may not be solved at their level. However, the problems / complaint from women employees which comes to their notice and the action taken report after solvency of such problem complaints must be submitted to the Chairperson of the University level Women Protection Cell under information to the University.
